I would specifically like to thank Senior Management who work closely with the Board. Christine Elliott, Lisa Gales, Mindy Jenner, and others – thank you for keeping us on track to ensure the Board meets all of our obligations.

I would like to thank our Executive Director, Jessica Smith who has always shown steady leadership but particularly so during the recent health care crisis. We appreciate your hard work and dedication to St. Andrews', - and we congratulate you on the recent addition to your family.

I would also like to recognize Glen Norton who is our Interim Executive Director. Glen has only recently started with St Andrew's but is already doing a great job in taking on this role. I would like to extend a special thank you to the Interim ED hiring committee that we put together, which also included Margaret Anderson, the Hospice Chair. You did a great job finding the right person for the job. And again - best of luck Glen.

I would like to thank all of our volunteers that have chosen St Andrew's as the place to donate their time. Programs like the Auxiliary and Meals on Wheels would not be able to carry out the important services they provide without the time generously given by our wonderful volunteers.

I would like to thank our community partners, St Andrew's Church, St Andrew's Terrace, and the Chatham-Kent Hospice. We are more than just neighbours and shared services – we are compliments to each other – and are we are looked upon as an example of successful partnerships to other communities.

Lastly, I would like to thank all the Board Members and the Community Members, who have dedicated their time to help St Andrew's enrich the lives of seniors in Chatham-Kent. A special thank you to the committee chairs for their added service. This year we say goodbye to retiring members, Les Herman, Devon Hanson and Betty Manso. We very much appreciate the time and effort you have given to St Andrew's.

As the pandemic slowed down over the past year, we chose to continue to meet virtually for our Board and Committee meetings. Although this was not anyone's preferred choice, it did not stop us from

completing all of our required tasks as well as taking on new exciting projects. I would now like to take a moment to highlight some of our successes.

I will start with the Foundation. In the past, our Foundation was very integral in providing the Residence with much needed financial support for both the resident day to day needs and large capital projects. In recent years however, as St Andrew's has become busy, - growing both inside our walls and outside in the community - the Foundation has not been able to be as active as it was in the past. We are now focused on changing this. With the help of Lynn McGeachy, who has been named the Executive Director of the Foundation (along with Foundation Board Chair Barry Fraser), we have begun to revitalize this important piece of St Andrew's that has so much potential. With St Andrew's being in a great fiscal position, it was decided to move our reserves over to the Foundation to be properly invested for the future use of the Residence. As well, existing and new Foundation members are currently working on new plans that will further rejuvenate this important piece of St Andrew's Residence. Thank you, Lynn, for your leadership with the Foundation.

Meals on Wheels continues to be a very important program that we are proud to offer through St Andrew's. Over the past year, our Meals on Wheels clients have increased allowing us to help even more members of the community. Seniors Day out remains challenging based on the pandemic, but staff has done a great job in doing there best to keeps these clients connected. This year we were notified that our funding for the Restorative Program was ending. This program was very beneficial to the community and although it is ending, this change will allow St Andrew's to provide more long-term beds for our residents.

St Andrew's was able to apply for and receive several grants this year. In total we received close to half a million dollars from various community and government sources. These funds have been used for equipment for the Residence, extra staffing throughout the pandemic, Meals on Wheels support – including our truck and to assist in our upcoming kitchen renovation. We are very appreciative for these generous grants.

Ontario Health Teams across the province have continued to develop, despite an initial slow down due to Covid. Our local OHT team has been progressing well and Jessica Smith (with Glen Norton currently filling in) continue to be much valued members of the steering committee as this large project develops.

Other noteworthy items to mention from the last year include the fact that covid outbreaks were very low and handled very professionally. St. Andrew's has maintained a very high occupancy level throughout the year, helping our financial position has remained strong. As mentioned, we are about to undertake a large kitchen renovation. This project will create some short-term logistics challenges, but the result will benefit the residence for years to come.

It was another very successful year for St Andrew's.

In closing, I would like to thank all of you for allowing me to be the Board Chair over the past two years. I have really enjoyed being a part of St Andrew's history and working with each of you. I welcome Judith

Lacina as the new incoming Chair and wish all the existing and new Board members much success in the upcoming year.

Community Programs and Partnerships Committee

Annual Report June 2022

This past year has been one of growth and development as we welcomed new Board Members, Sharon Chapple and Cindy Waddick to the committee and we became more familiar with our new terms of reference and refined the workplan. The focus of our committee is to

- 1. monitor trends in Senior's care,
- 2. monitor and evaluate programs and services,
- 3. assess market share and community needs,
- 4. review current partnerships and identify future partnerships that support STAR strategic priorities
- 5. support development of volunteer resources
- 6. advise the Board of risks and opportunities related to the committee's scope

Overview:

- Meals on Wheels annual satisfaction surveys from both clients and volunteers were reviewed and results were presented to the Board. Responses continue to be very positive, specifically identifying that both groups felt safe and protected with the Covid-19 precautions implemented by STAR.
- **Resident Satisfaction survey** results were reviewed and reported to the Board. On our recommendation, of the reporting format was revised to show year over year comparisons. Resident satisfaction remains strong despite the ongoing disruptions caused by a pandemic outbreak and resulting restrictions. Evidence of follow-up of resident concerns and problem solving is reported to the committee and subsequently shared with the Board.
- **Student Satisfaction Surveys** have been developed, with strong feedback from the respondents. Clinical placements and Co-op opportunities have been limited due to Covid 19.
- Volunteer resources and opportunities increased as Covid 19 restrictions eased. We continue to support
 recruitment, needs, and use of a skills matrix. The committee recommended that STAR volunteer satisfaction
 survey results be reported separate from Meals on Wheels. The Volunteer Recruitment and Diversity Policy was
 reviewed.
- **Community Partnership Evaluation** tool was developed and piloted with good feedback. Its purpose is to establish criteria and assist board decision making about potential new partnerships collaborations and alliances. The tool will be further reviewed after STAR administration has an opportunity to trial it further.
- Programs and Services continue to be impacted by Covid-19 restrictions. Seniors Day Out, funded through
 Ontario Health, remains a challenge as it currently cannot be hosted on site. We are supportive of plans to
 investigate a different delivery and staffing model.
- Trends in Seniors' Care were reviewed with updated information charting comparisons in the various levels of services and costs offered by local Long Term Care homes and other Retirement Homes in Chatham-Kent. STAR remains very competitive being the only not for profit model locally, with a strong market share evidenced by our current waiting list for admission.
- **Risk** identification specific to CPPC scope was developed. CPPC Chair and senior management are working to update the Risk Management plan, assigning scores and mitigation processes to determine priorities.

The Community, Programs and Partnerships Committee is privileged to have two community members, Linda Reiger and Betty Manso, supporting our work, and providing their expertise. We are very grateful for the many

hours contributed this past year. After many years of service, Betty will be leaving CPPC. Her clinical nursing background, and thoughtful insight have been an invaluable resource. We are very grateful and wish her well.

On behalf of our Committee, I would like to acknowledge Lisa Gales, Christine Elliott, Mindy Jenner, and Jessica Smith for tremendous support and assistance throughout this very challenging year. We look forward to the coming year under the leadership of Glen Norton.
