Board Chair Annual Report

I am very honoured to present the St. Andrew's Residence Board of Directors annual Chair's Report for 2022-2023.

At the Board level, and at the organization level, we have much to be proud of, successfully navigating our way through a year that could be described as one of "Transitions."

Transition within the leadership team, transition of board membership and roles, transition to new infrastructure with the kitchen renovation, transition in and out of Covid outbreaks and restrictions, transition to in-person meetings, transition to a revitalized Foundation, transition to expanded outreach programs...

This report will highlight the various milestones and achievements of this past year. I hope you will agree that our mission of Enriching the lives of senior in Chatham-Kent and our vision of Providing a home where seniors enjoy an exceptional quality of life and well-being, were successfully achieved.

Your lives are busy; we are so grateful you choose to share your time with St. Andrew's. On a personal note, I am very appreciative of the support each of you has shown me during my first year in this Chair role.

I would like to make special mention of 3 people for whom this will be their final Board meeting.

Sharon Chapple is transitioning from her current director role to become a St. Andrew's Residence Auxiliary member. Her contributions over the past 2 years to the CPPC committee and to the Board have been insightful. Sharron's knowledge and experience with Veterans, and familiarity with services offered by other retirement and long-term care organizations have been of great benefit to our Board. We are very pleased that she will be continuing her involvement with St. Andrew's with the Ladies Auxiliary.

Darrin Utley has been involved with St. Andrew's Residence for the past 10 years. He served as a community member of the Finance Committee from 2013 – 2016. He joined the Board of directors in 2016 and subsequently served as chair of the finance committee from 2016-2018, and then again in 2022-2023. He took on a leadership role in 2019-2020 in the role of vice chair and then became our Board Chair for 2021-2022. He has also served as STAR's representative on the Terrace Board, and more recently as a community member for the St. Andrew's Residence Foundation Board.

We are so very grateful for Darrin's exceptional commitment, expertise, and leadership over the past decade. He successfully led the Board through the challenges brought by Covid, senior staff vacancies and the development of the STAR Foundation executive director role. Darrin guided many important recommendations from the finance committee as we embarked on capital projects and the re-vitalization of the Foundation. Again, thank you for your important and lasting contributions.

Glen Norton has served as our interim Executive director for the past year and will be leaving us in September when Jessica Smith returns from her leave. Glen has successfully led us through a very challenging year with the major kitchen renovation, 2 Covid outbreaks, front line staff shortages, a lengthy vacancy of the finance manager position, the withdrawal of Ministry funding for the restorative program, the sad loss of Lynn McGeachy, as well as his responsibilities to the Hospice and the Terrace. His leadership skills and forward strategic thinking have been of immeasurable value. Many of the organizational achievements identified earlier in this annual report were initiated by Glen. He has contributed much to the success of our organization and we are very grateful for his outstanding commitment to St. Andrews Residence and our community partners over this past year.

Glen, we appreciate all you have done and you will be missed.

As noted at the beginning of this report, we have much to be proud of. And I am confident we have much to look forward to in the coming year as we continue to transition and grow with the development of our next strategic plan.

This past year we were happy to welcome a new Community Member, Rose Scott, to the committee.

We became more aware that our Terms of Reference continue to need adjusting in order to fulfill our purpose as the focus of our committee is to

- 1. monitor trends in Senior's care,
- 2. monitor and evaluate programs and services,
- 3. assess market share and community needs,
- 4. review current partnerships and identify future partnerships that support STAR strategic priorities
- 5. support development of volunteer resources
- 6. advise the Board of risks and opportunities related to the committee's scope

Overview:

- Meals on Wheels Satisfaction Surveys continue to show very positive results. The number of meals continues to increase with a large volunteer base making this program a huge success.
- **Programs and Services: Seniors Day Out,** funded through Ontario Health, has been re-implemented this year now that Covid restrictions have been lifted. The expansion of the program to rural areas, such as Dresden, is a great benefit to the Chatham-Kent Community. Expectation is that Tilbury and other areas will be served in the near future. We are very excited about the possibilities that this programming offers to many in our community.
- Resident Satisfaction Survey: Resident satisfaction remains positive, with residents feeling safe and well-cared
 for. The follow-up of resident concerns and problem solving by the staff is always handled in a timely and
 complete manner.
- **Student Satisfaction Surveys:** Due to Covid restrictions, and the small number of student placements, we will resume these surveys in the upcoming year.
- **Risk Management:** The Risk Register was updated by the Chair and Sr. Management, was reviewed in January and was presented to the Board in February.
 - Quality indicators reported on the Balanced Score Card are being reviewed by CPPC on a trial basis prior to presentation to the Board. CPPC Terms of Reference will be modified depending on the outcome of the pilot.
- Volunteer Resources: Happily, we were finally able to acknowledge our volunteers with an in-person Volunteer Appreciation Brunch earlier in June. The turnout was excellent and enjoyed by all in attendance. The Strawberry Social, organized by the Ladies Auxiliary on June 15th, was a huge success! Many thanks to Linda and all of the volunteers who contributed to this wonderful event.

On behalf of our committee, we would like to acknowledge Lisa Gales, Christine Elliott, Mindy Jenner, and Glen Norton for tremendous support and assistance. We have appreciated the leadership that Glen has provided and wish him well in his future endeavours. We also thank Sharon Chapple for her commitment and dedication to St. Andrew's, specifically with her work on the CPPC. As she leaves the Board and changes roles, we know that we will see her continue to serve the residents of St. Andrew's in the future.
